A) Eligibility Criteria :-

- i) The resource person/financial advisor should be a former cooperative background officer preferably retired from Cooperative banks/nationalized bank not below the rank of GM/DGM/Senior Manager having atleast two years experience as a CEO of any DCCB.
- ii) The resource person/financial advisor should have sufficient experience in designing loan products and design loan products in competitive market.
- iii) The academic qualification of resource person/financial advisor should be a post graduate and have atleast ten years experience in credit appraisal.

B) Duties :-

- i) To undertake potential assessment, keeping in view the business profile of the bank, for improvement in investment policy.

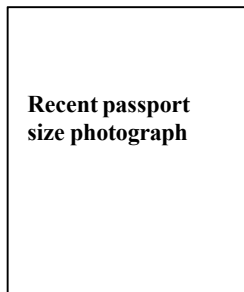
